**Useful Information [**

- Comment [c1]:** The national Bureau can add its logo, if it wants to do so
- Comment [c2]:** The title of the document has to be written in English and French and in the language or languages of the national Bureau. The order of the languages used for the title of the document is left at the discretion of each national Bureau.
- Comment [c3]:** The Name of the national Bureau under which the document is issued should be stated.
- Comment [c5]:** Reference numbers have to be mentioned to allow for the identification of the document.
- Comment [c4]:** The period of validity of the document has to be mentioned
- Comment [c6]:** The number of the registration plates of the vehicle or its chassis or engine number (if the registration is not available) have to be mentioned.
- Comment [c8]:** The make of the vehicle covered by the document has to be mentioned.
- Comment [c7]:** The category of the vehicle has to be mentioned, using one of the codes herebelow
- Comment [c9]:** The Territorial validity of the document has be indicated. An insurer can decide not to cover some countries (hence the country not covered will be crossed). However, a Green Card issued for one of the EU Member States has to cover all the other EU Member States as well (& thus none of these countries can be crossed out).
- Comment [c10]:** The name & the address of the policyholder or the user of the vehicle has to be mentioned
- Comment [c11]:** The name & address of the insurer that issued the document has to be mentioned. The Insurer can also decide to add some further information such as the logo of its company, its phone N°, etc....
- Comment [c12]:** The insurer has to sign the document
- Comment [c13]:** The insurer can decide to add any kind of additional information that s/he believes useful for the policyholder.
